RESOLUTION NO. 2018-4

A RESOLUTION DECLARING CERTAIN AREAS WITHIN THE TOWN OF CORYDON, INDIANA AN ECONOMIC TARGET AREA FOR PURPOSES OF REAL PROPERTY TAX ABATEMENT

WHEREAS, the Town Council of the Town of Corydon recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and,

WHEREAS, the Council further recognizes that is in the best interest of the City to provide incentives to stimulate investment within the community; and,

WHEREAS, Indiana Law at IC 6-1.1-12.1-7 provides for a program of real property tax abatement within "economic target areas"; and,

WHEREAS, pursuant to said IC 6-1.1-12.1-7 the Town desires to establish such an "economic target area" within the Town of Corydon; and,

WHEREAS, a certain area shown on Exhibit "A", a copy of which is attached hereto, which is within the corporate limits of the Town of Corydon, has become undesirable for, or impossible of, normal development and occupancy because of lack of development, cessation of growth, deterioration of improvements or character of occupancy, age, obsolescence, substandard buildings, or other factors which have impaired values or prevent a normal development of property or use of property.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Corydon, Indiana that said area within the corporate limits of the Town of Corydon, Indiana is an economic target area within the meaning of Indiana Code 6-1.1-12.1-7.

BE IT FURTHER RESOLVED by the Town Council that a copy of this Resolution and exhibits, shall be filed by the Clerk Treasurer of the Town of Corydon, Indiana, with each taxing unit that has authority to levy property taxes in the geographic area where the economic target area is located.

BE IT FURTHER RESOLVED that this Resolution shall be in full force and effect on the date of its approval.
