

**ORDINANCE NO. 2016 - 14**

**ORDINANCE TO AMEND ORDINANCE NO. 2016-13**

**WHEREAS**, the Town Council of the Town of Corydon, Indiana, (the "Town") desires to amend the existing Ordinance creating a Historic Preservation Commission;

**WHEREAS**, the Town believes that such amendment to the Town's Historic Preservation Commission Ordinance will best serve the goals of establishing an effective Historic Preservation Commission with oversight over historic buildings within the Town of Corydon;

**WHEREAS**, the Town desires to not limit the jurisdiction of the Historic Preservation Commission to the floodplain area;

**WHEREAS**, the Town desires to amend the Historic Preservation Commission Ordinance to provide for a better makeup of the membership of the Commission and to not limit the jurisdiction of the Historic Preservation Commission to the floodplain area;

**NOW, THEREFORE BE IT ORDAINED** by the TOWN COUNCIL OF THE TOWN OF CORYDON, INDIANA that the existing Historic Preservation Commission Ordinance (2016-13) be amended as follows:

**Section 3. Historic Preservation Commission Establishment and Organization Subsection b.** shall strike the sentence reading "All members of the Commission shall be residents of Harrison Township in Harrison County, Indiana and at least one (1) member shall be a resident of the Town of Corydon, Indiana." Such sentence shall be replaced by the following: "All members of the Commission shall be residents of Harrison Township in Harrison County, Indiana or own real property within the Town of Corydon, Indiana and at least one (1) member shall be a resident of the Town of Corydon, Indiana."

All other provisions of Section 3, Subsection b. shall remain in effect.


**NOW, THEREFORE BE IT FURTHER ORDAINED** by the TOWN COUNCIL OF THE TOWN OF CORYDON, INDIANA that the existing Historic Preservation Commission Ordinance (2016-13) be further amended as follows:

**Section 5. Historic Districts and Guidelines Subsection a.1.** shall strike the last sentence stating "The jurisdiction of the Commission shall be limited to only properties located within the floodplain."


All other provisions of Section 5, Subsection a.1. shall remain in effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage by the Town Council of the Town of Corydon, Indiana.
