A RESOLUTION ACCEPTING ASSIGNMENT OF TAX SALE CERTIFICATES TO THE TOWN OF CORYDON, INDIANA

WHEREAS, the Town of Corydon, Indiana, by and through its Town Council, is the assignee of tax sale certificates on the properties described in EXHIBIT A attached hereto;

WHEREAS, pursuant to IC 6-1.1-24-9, the Harrison County Board of Commissioners may assign tax sale certificates held in the name of the county executive to any political subdivision;

WHEREAS, the Town of Corydon, Indiana has agreed to accept the assignment of tax sale certificates on the properties described in EXHIBIT A and has requested from the Harrison County Commissioners an assignment of those specified tax sale certificates; and



NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CORYDON, INDIANA


1. That the Town of Corydon, Indiana by and through its Town Council, hereby accepts the assignment of those tax sale certificates held by Harrison County to the Town of Corydon, Indiana for the properties described in EXHIBIT A attached hereto.
2. That all taxes, penalties and assessments against the properties described herein shall be waived for the tax year 2015 payable 2016 and all years prior as to the Town of Corydon, Indiana.
3. That the period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date the certificates are assigned pursuant to applicable law.

PASSED AND ADOPTED by the Town Council of Corydon, Indiana this 27th day of June, 2016.






