2. That all taxes, penalties and assessments against the properties described herein shall be waited for the tax year 2015 payable 2016 and all years prior as to the Town of Corydon, Indiana.
3. That the period of redemption of the properties described herein shall be for one hundred twenty (120) days from the date the certificates are assigned pursuant to applicable law.
